# RP Campaign 2018!!

Once again ladies and gentlemen we were very successful in our 2018 ASHRAE RP Campaign Year which ended on June 30, 2018. Our Goal for the Dayton Chapter was \$18,600 and our final tally was \$19,459, thereby finishing 4% over our Goal.

Thanks so much to the generosity and forward-thinking donors assuring that ASHRAE Research will continue to lead the way in the quality of life for all Americans as well as the world. Your dollars fund research projects, many of which end up being parts of the ASHRAE Standards, or supporting ASHRAE Standards that then become codes guiding continuous improvement in the built environment.

#### **Building Energy Conservation Bill Introduced**

On July 27, Senators John Hoeven (R-ND) and Joe Manchin (D-WV) reintroduced S. 3295, "All-ofthe-Above Federal Building Energy Conservation Act." The bill would require existing buildings that have undergone a major renovation to be 30% more efficient than the most recent International Energy Conservation Code or <u>ASHRAE 90.1 Standard</u> which is already required by new federal buildings. The bill would also increase energy efficiency in federal buildings by requiring energy managers to implement any energy or water saving measure that is life cycle cost-effective within two years of completing an evaluation. Reps. Buddy Carter (R-GA) and Gene Green (D-TX) introduced H.R. 6584, a companion bill in the House.

#### Passes Legislation to Reauthorize Carl D. Perkins Career and Technical Education Program

On July 31, President Trump signed The Strengthening Career and Technical Education for the 21st Century Act into law which updates the Carl D. Perkins Career and Technical Education Program. The Senate passed the bill unanimously on Monday, July 23 while the House unanimously passed it on Wednesday, July 25. The \$1.1 billion program, last reauthorized in 2006, provides funding for job training and related programs for high school students, many of whom may be seeking postsecondary options other than a four-year college degree, as well as for students in higher education. ASHRAE signed a letter in support of this legislation in June with several other organizations.
