Presentation Topic: The Low GWP Refrigerant Transition: Regulatory Landscape and options for HVAC&R Equipment





ASHRAE Holds a Government Outreach Day in Maryland

On January 9, members from ASHRAE's Baltimore and National Capital Chapters met in Annapolis, Maryland to meet with state legislators. 11 ASHRAE members attended and they conducted meetings with 29 legislators and their staff. Members provided them with an introduction to ASHRAE and explained how ASHRAE can be a source of technical expertise for future legislation involving building energy efficiency standards, HVAC equipment, refrigerant safety, Legionella disease, and indoor air quality among other issues.

European Union Reviews Climate Goals and Launches Sustainable Europe Investment Fund

The Parliament of the European Union (EU) voted 482 to 136 to pass the European Green Deal, which calls for the EU to be carbon neutral by 2050. The Parliament also has pushed for more aggressive 2030 and 2040 targets. To spur the EU's transition to a climate-neutral economy by 2050, the European Union is providing about \$1 trillion in financing to spur green investments across all sectors of the economy. For areas of the EU which will be more highly impacted due to higher employment in fossil fuel production, the EU is providing "The Just Transition Fund" to help these countries with their transition. Energy and Commerce Subcommittee Holds Hearing on HFC Phasedown Legislation

On January 14, the Subcommittee on Environment and Climate Change held a legislative hearing entitled, "Promoting American Innovation and Jobs: Legislation to Phase Down the Use of Hydro-fluorocarbons." The hearing focused on H.R. 5544, the "American Innovation and Manufacturing Leadership Act," which was introduced by U.S. Representatives Paul Tonko (D-NY-20), Pete Olson (R-TX-22), Scott Peters (D-CA-52), and Elise Stefanik (R-NY-21) on January 7. House Energy and Commerce Committee Releases Draft Climate Legislation

On January 8, Democrats on the Energy and Commerce Committee <u>released</u> a legislative framework of its plan to tackle the climate crisis which includes a section on buildings. The legislation was developed after committee staff issued a questionnaire and held several meetings with stakeholders, including <u>ASHRAE</u>. On January 16, House Republicans held a conference-wide meeting on the issue of climate change to outline a proposal for climate legislation. The gathering featured presentations from Climate Crisis Committee Ranking Member Garret Graves (R-LA); Energy and Commerce Ranking Member Greg Walden (R-OR); and Rep. Bruce Westerman (R-AR).

2019 Second-Hottest Year Since Record-Keeping Began

On January 15, NASA and NOAA reported that 2019 was the second warmest year since 1880, when record-keeping began. 2016 was the hottest year. The federal agencies also reported that the past decade (2010–2019) was the hottest decade on record. More information about temperature records and the state of the climate can be found here.





Energy Department Accelerates Energy and Water Efficiency Advancement at Federal Facilities via Performance Contracts

The U.S. Department of Energy has announced more than \$5 million in funding for 11 federal agency projects to fully utilize energy and water efficiency and renewable energy technologies. To view the projects, click here.

DOE Publishes Final Rule for Efficiency Standards of Appliances

The U.S. Department of Energy (DOE) has published new rules that will go into effect on March 10 that set energy efficiency standards for equipment such as <u>commercial packaged boilers</u>, <u>portable air conditioners</u>, <u>industrial air compressors</u>, and <u>uninterruptible power supplies</u>. The rules were <u>published</u> following decisions from both a federal district court and the 9th Circuit Court of Appeals last year after they were delayed by DOE.

City of Columbus, Ohio Proposes Energy and Water Building Performance Ordinance

The City of Columbus has proposed a city council ordinance with new requirements for building energy and water benchmarking, reporting, and transparency. The ordinance would apply to city-owned property that exceeds 25,000 gross square feet, and to non-city property that exceeds 50,000 gross square feet. The city is accepting comments through January 31, 2020. More information about the proposed ordinance can be found here.

AHRI Seeking Volunteers for Safe Refrigerant Transition Task Force Speakers Bureau

The AHRI Safe Refrigerant Transition Task Force supporting the transition to low global warming potential (GWP) refrigerants created a Speakers Bureau in cooperation with ASHRAE and other organizations. The Speakers Bureau will maintain a list of capable presenters on various topics related to the transition to low GWP refrigerants and match those individuals to groups seeking more information about the transition. Topics could include regulatory requirements, technician training, DOT requirements, first responder training, general properties of low GWP refrigerants and others.

When opportunities arise, the AHRI Speakers Bureau will reach out to experts in the specifically needed topic areas and ask volunteers if they are available for that specific event providing the event, date, location and materials to be presented attempting to match preferred locations and timing to accommodate volunteers' schedules and minimize their travel as much as possible.
